The eligible candidates who passed out from Board of Intermediate, AP or other recognized Boards are eligible to participate in web counselling for the seats available in Undergraduate Programmes in Arts, Science, Social Sciences, Commerce, Management, Computer applications and Social Work, etc., leading to the award of B.A., B.Sc., B.Com., BBA., B.Voc, B.F.A, 5 year integrated PG programmes with Intermediate qualification (with the exception of Engineering and Pharmacy streams) etc, in Government Degree Colleges, Government Autonomous Degree Colleges, Private Aided Degree Colleges, Private Unaided Degree Colleges, Private Autonomous Degree Colleges (Aided and Unaided) in the State of Andhra Pradesh for the academic year 2023-24. Candidates are informed that the online admission process comprising of registration, payment of processing fee will commence from 19.06.2023 and pending certificate verification at HLCs will commence from 22.06.2023.

GUIDELINES FOR FILLING VACANT SEATS UNDER SPOT ADMISSIONS BY DEGREE COLLEGES FOR 2023-24

1. The leftover vacancies after Phase-III of admission process, including seats under EWS quota in the institution can be accessed through the OAMDC portal from 16.10.2023
2. Notification in a Daily Newspaper shall be issued by the institutions indicating the number of vacancies course-wise and the date of commencement of Spot Admissions
3. Candidates passed with the prescribed 35% of marks in the qualifying examination shall be admitted under spot admissions
4. Eligibility criteria followed for making admissions under convener quota shall be strictly followed for making spot admissions
5. Candidates who satisfy the definition of Local/Non-Local shall alone be granted admission.
6. Candidates whose qualifying examination is from other state [except the state of Telangana which is not to be considered 'other state' in this context] but either of the parents resided for a period of 10 years in A.P/Telangana state are eligible for Spot Admissions.
7. Candidates possessing the qualifying examination certificate recognized as equivalent to Intermediate by Board of Intermediate Education of Andhra Pradesh shall be considered for admission. However 2/3 year Diploma Holders of NG Ranga Agricultural University and Dr.YSR Horticulture University are also eligible for admission into non-professional UG Programmes in accordance with G.O Rt. No.17 HE(CE A1) Dept Dt:10.02.2021
8. While admitting candidates under spot admissions, original certificates are to be verified and attested photocopies of certificates only are to be collected by the Principals/College Managements. The College shall return the original certificates to the candidates immediately after verification. However, the candidates shall produce the original certificates as and when required by the institution. Under no circumstances the college shall retain the original certificates with them, with the exception of TC and CC.

9. Fee as fixed by the A.P Higher Education and Regulatory Commission is to be collected after ratification of admission by the APSCHE in respect of Unaided Programmes in Private Aided and Unaided Degree Colleges
10. Candidates who have confirmed their admissions under phases I to III cannot be admitted under spot admissions unless they cancel their admission under convener quota.
11. The list of admitted candidates as per the order of merit, including the seats under EWS category are to be uploaded along with documental proofs for scrutiny and ratification of admission. The list of certificates which are to be uploaded are:

12. Seats under EWS are to be filled with eligible candidates belonging to OC category with a valid EWS certificate only.

The Principals of all the Self-Finance Private Engineering / Standalone MBA/MCA colleges in AP state are informed that APICET-2023 Admissions are completed 25-11-2023 and the students were instructed to report at colleges.

All the Self Finance Private Engineering/Standalone MBA/MCA colleges are requested to fill up the left over and dropout vacancies by conducting Spot Admissions on or before 18-12-2023.

Principals are requested to comply with the following sequence of operations:

1. Collect original certificates from candidates for causing verification and the tuition fee admissible.
2. Update the joining details by logging into <https://cets.apsche.ap.gov.in> with the user ID already being used for updating joining details.
3. Derive Spot Vacancy. The unfilled and not joined / dropout vacant seats will now become vacancies for Spot admissions.
4. Conduct internal sliding to eligible candidates/branches. For this uncheck the check box against the candidate whom you are going to internally slide him/her to newer branch. Click on internal sliding, enter the hall ticket number and perform internal sliding.

INSTRUCTIONS FOR FILLING UP CATEGORY-B SEATS UNDER MANAGEMENT QUOTA & SUPERNUMERARY QUOTA FOR PIO/FN/CWG IN PRIVATE UNAIDED ENGINEERING AND STANDALONE COLLEGES OFFERING MBA, MCA COURSES FOR THE ACADEMIC YEAR 2023-24.

1. In terms of relevant G.Os and amendments issued from time to time, the schedule to fill up Category-B Management quota and supernumerary quota seats is detailed hereunder for the academic year 2023-24.
 - (i) Managements shall issue notification to fill 30% seats under Category-B (15% Non-NRI quota +15% NRI quota) admissions.
 - (ii) Managements who are accorded approval by AICTE to fill the specific category of seats under FN/PIO/CWG under supernumerary quota for the course concerned shall also notify.
 - (iii) Managements shall complete total admission process (i.e issue of notification, receipt of applications, finalization of list, reporting of students, etc.), under Category-B and supernumerary quota seats as per the schedule given.
 - (iv) The Managements shall close all admissions in compliance of the Judgment of Hon'ble Supreme Court of India.
2. The institutions that are approved by All India Council for Technical Education (AICTE) and permitted to fill NRI seats of the sanctioned intake in each course for the academic year 2023-24, shall admit NRI candidates (sons and daughters of NRIs) who have passed the qualifying examination with not less than 50% aggregate marks in the qualifying examination or Cumulative Grade Point Average (CGPA) equivalent to 5 on a scale of 10.
3. The remaining seats shall be filled on merit basis with the candidates under A.P. Presidential Order 1974 who have secured rank in any all India Common Entrance Test for the respective program and secured not less than 50% of marks in the qualifying examination.
4. The seats remaining unfilled from (2) and (3) above shall be filled with eligible candidates, who have qualified in the APICET-2023 examination on merit basis following eligibility criteria laid in the GOs concerned.
5. Thereafter, if any seats still remain unfilled, such seats may be filled on merit basis with candidates securing not less than 50% (45% in case of candidates belonging to reserved categories) of marks in the prescribed group subjects taken together/aggregate marks in the qualifying examination (10+2+3 or its equivalent), as prescribed, under A.P Presidential Order 1974.

6. Any vacant seats, after filling up of all seats under AP Educational Institutions (Regulations and Admissions) Order 1974, as subsequently amended, shall be filled as per the instructions issued by the Competent Authority from time to time.
7. The Institutions shall follow the procedure mentioned below to conduct the admissions:
 - (i) The Institution shall facilitate a web portal for filling up Category-B (Non-NRI) and 15% NRI quota seats.
 - (ii) The management of the Colleges shall notify the details of courses offered with intake, schedule of admissions (date wise), and registration fee for the application, minority or non-minority status in leading news dailies, either in English or Telugu.
 - (iii) The web portal shall provide the students, the facility for making online applications for Category-B(Non-NRI)and 15% NRI quota seats. A printable/recordable electronic acknowledgement shall be provided to the student on successful uploading of online application. This will dispense with the need for the student to physically visit each and every college besides ushering in transparency.
 - (iv) The students shall also be provided an option to submit their applications, in person, at the college of their choice.
 - (v) The management of the college has the option to call the selected candidates to appear in person for interview to substantiate their credibility and financial capacity to its satisfaction. In the event of the management finding that any of the selected candidates is not suitable for admission, the management shall be at liberty to reject the candidature of such candidates and the reasons should be communicated to the Competent Authority.
 - (vi) All admissions to the Category 'B' seats shall be completed in compliance of the judgement of Hon'ble Supreme Court of India.
 - (vii) The web portal shall be opened for all students desirous of seeking admission to Category 'B' quota seats in Private Un-Aided Professional colleges in the State. Candidates can apply to colleges of their choice by visiting the portal only during the dates notified by the Competent Authority.
 - (viii) A candidate can select any of the college/colleges and apply online for seeking admission to Category 'B' seats of college/colleges after paying the requisite registration fees as notified by the college.
 - (ix) The candidate can also give his order of preference for admission to a college by giving the order of preference from among the courses offered by the college in the online application form. Only one form needs to be filled for a college regardless of the number of options.
 - (x) A candidate can apply for more than one college by visiting the respective website of colleges and apply online after paying the registration fees specified for each college.

- (xi) No new application shall be accepted after the closing date of admissions to the college.
- (xii) The Management of the college shall administer the selection process as per the admission procedure specified. Each college shall download the data of the applications received, after the closing date as notified by the Competent Authority.
- (xiii) The Institution shall generate the merit list which will be in order of NRI quota (if available),rankers of all India common entrance test for respective program, APICET- 2023 rankers and qualifying examination in order of merit as prescribed in these instructions.
- (xiv) The selection of candidates shall be done by the college managements themselves, as per the merit of the candidates.
- (xv) The selection list, after selection process is completed by the management of respective colleges as per the prescribed norms, shall be uploaded by the managements on the website of the institution.
- (xvi) In case of unfilled seats if any, the concerned colleges shall admit candidates in order of merit from the merit list (second selection list).
- (xvii) After completion of the admission process, the college managements shall upload in the web portal provided by the Competent Authority and forward the list of admitted candidates and also for ratification by the Competent Authority as per the prescribed schedule.
- (xviii) The Institution shall furnish information in accordance with the instructions issued for submission of admission lists by the Competent Authority.
- (xix) The Competent Authority will verify the list of the selected candidates and validate the same with reference to the G.Os and the procedure prescribed by the Competent Authority.
- (xx) The Competent Authority shall approve the validated list, if found tallying by cross validation process or reject the lists, if found to be at variance to the rules and procedures prescribed and communicate the same to the concerned colleges for compliance.
- (xxi) Applications of candidates not fulfilling the required conditions during the validation of the list by the Competent Authority will summarily be rejected.
- (xxii) The Management shall collect the Tuition fee as prescribed by the Government for Category-'B' seats and any excess fee collected will amount to capitation fee and Managements are liable for action under A.P. Educational Institutions (Regulation of Admissions and Prohibition of Capitation fee) Act, 1983.
- (xxiii) Any complaint/appeal against the selection shall be made to the Competent Authority.

(xxiv) The managements shall comply with the above instructions and failure in implementing the same shall entail action as per the relevant Acts and Rules in force.

- 8 The Institution shall undertake the responsibility on the irregularities noticed by the Competent Authority.
- 9 The Competent Authority shall have the authority to impose fine or to initiate action or both for violation of Instructions as per the G.O's in vogue.
- 10 Proceedings for the ratification/rejection of admissions made after verification of eligibility criteria, the Council will inform the date from which approval proceedings can be downloaded through the website.
