## Memorandum of Understanding

Between

Dimensions Coaching Center

and

ST. ANN'S COLLEGE FOR WOMEN

This Memorandum of Understanding (MOU) is entered into on the 2nd day of August, 2020 by and between Dimensions Coaching Center (hereinafter called DCC) situated at 4/12, Brodipet, Guntur-522002, (Andhra Pradesh).

And

ST. ANN'S COLLEGE FOR WOMEN, Amaravathi Road, Gorantla, GUNTUR-522034.

The aforesaid institutions are hereinafter referred to individually as *institute* and collectively as *institutes*.

### A) OBJECTIVES OF THE MoU

The objectives of the MoU are:

1. To promote awareness among the students of St. Ann's College for Women, about the various government job opportunities that they have as per their educational qualification.

2. To promote awareness among the students of St. Ann's College for Women, the details of the various government job notifications and respective exam patterns.
3. To train and empower the students of St. Ann's College for Women, to enable them to attempt the various government job notifications as per their educational qualification.

## B) TERMS AND CONDITIONS

The above objectives will be accomplished by undertaking the following activities:

1. DCC will provide the training for government job examinations to the students of St. Ann's College for Women, batchwise.
2. For a batch the training programme will last for a period of 100 hours.
3. The training programme can be continued to subsequent batches in the same year and also in the years to come.
4. DCC will provide Faculty members and the requisite material, handouts and tests to the students of St. Ann's College for Women, who have joined the training programme.
5. St. Ann's College for Women will provide the necessary infrastructure like Classroom, Chalk, Water, Benches etc until the end of the training programme.
6. Both the *institutes* agree that their respective resources (faculty members of DCC & Students of St. Ann's College for Women) maintain discipline and decorum in the conduct of the training programme.
7. For providing the training to the students of St. Ann's College for Women, the financial arrangements will be made as per the mutually agreed terms.
8. This MoU may be amended, renewed and terminated by mutual written agreement of the *institutes* at any time.
9. Either *institute* shall have the right to terminate this MoU upon 60 days prior written notice to the other *institute*.

## C) CONFIDENTIALITY

Both the *institutes* agree to hold in confidence all information/data designated by the *institutes* as confidential obtained from either *institute* or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other *institute*.

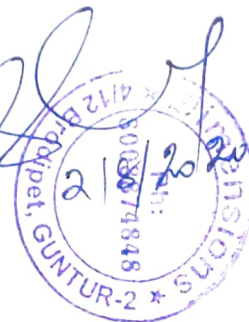
The above confidential clause under this MoU excludes the information or data possessed by either *institute* before entering this MoU or independently developed and/or information already available through public domain

## D) Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from both the *institutes*. This MOU shall become effective upon signature by the authorized officials from both the *institutes* and will remain in effect for a period of five years (i.e. upto 2<sup>nd</sup> August 2025) until modified or terminated by any one of the *institutes* by mutual consent.
